**THE BOROUGH OF BROXBOURNE (VARIOUS ROADS)
(DISABLED PERSONS' PARKING PLACES) ORDER No.2 2021**

NOTICE is hereby given that the Council of the Borough of Broxbourne, pursuant to arrangements made with Hertfordshire County Council under Section 19 of the Local Government Act 2000 and the Local Authorities (Arrangements for the Discharge of Functions) (England) Regulations 2000, propose to make an order under Sections 32, 35 and Part IV of Schedule 9 of the Road Traffic Regulations Act 1984, the effect of which is to:


