

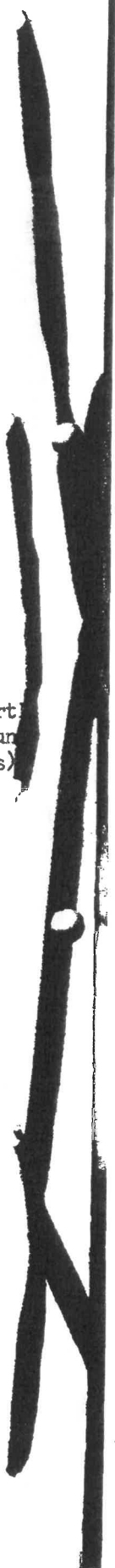

The Borough of Broxbourne (Hedworth Avenue and Clarendon Road, Cheshunt) (Waiting and Loading Restrictions) Order 1975

The Council of the Borough of Broxbourne (hereinafter referred to as "the Council") in exercise of their powers under Section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, and pursuant to arrangements made under Section 101 of the Local Government Act 1972 with the County Council of Hertfordshire, and of all other powers enabling in that behalf, and after consultation with the Commissioner of Police of the Metropolis in accordance with Section 84C (1) of the said Act of 1967, hereby make the following Order:-

1. Save as provided in Article 2 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait between the hours of 8.00 a.m. and 6.30 p.m. Mondays to Saturdays inclusive in the lengths of road specified in the Schedule hereto
2. Nothing in Article 1 of this Order shall render it unlawful to cause or permit any vehicle to wait in any of the lengths of road referred to in those Articles, as the case may be, for so long as may be necessary:-
 - (a) to enable a person to board or alight from the vehicles;
 - (b) to enable goods to be loaded or to be unloaded from the vehicle except between the hours of 8.00 a.m. and 9.30 a.m. and also between the hours of 4.30 p.m. and 6.30 p.m. Mondays to Saturdays inclusive;
 - (c) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the road, of the side of the road or of any of the lengths of road so referred to or the laying, erection, alteration or repair in or

- (d) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority in pursuance of statutory powers or duties; or
- (e) to enable the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said road, the said side of road or any of the said lengths of road

3. The prohibitions and restrictions imposed by Article 1 of the Order shall not apply to the following vehicles, that is to say:-

- (a) vehicles while waiting upon a duly authorised parking place, or
- (b) hackney carriages while waiting at a duly authorised cab rank

4. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the Road Traffic Regulation Act 1967 as amended as aforesaid or by under any other enactment

5. The Interpretation Act 1889 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament

6. This Order shall come into operation on the 15th day of December 1975, and may be cited as the Borough of Broxbourne (Hedworth Avenue and Clarendon Road, Cheshunt)(Waiting and Loading Restrictions) Order 1975

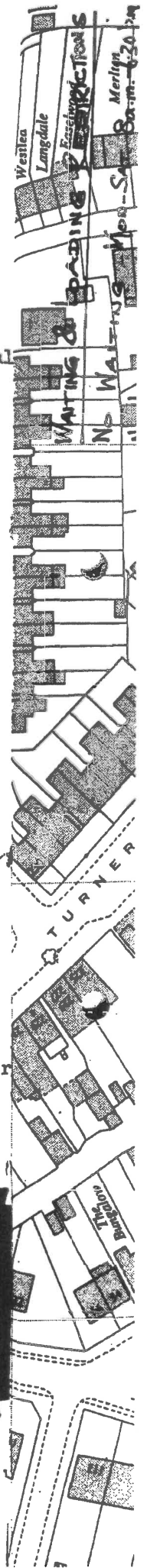

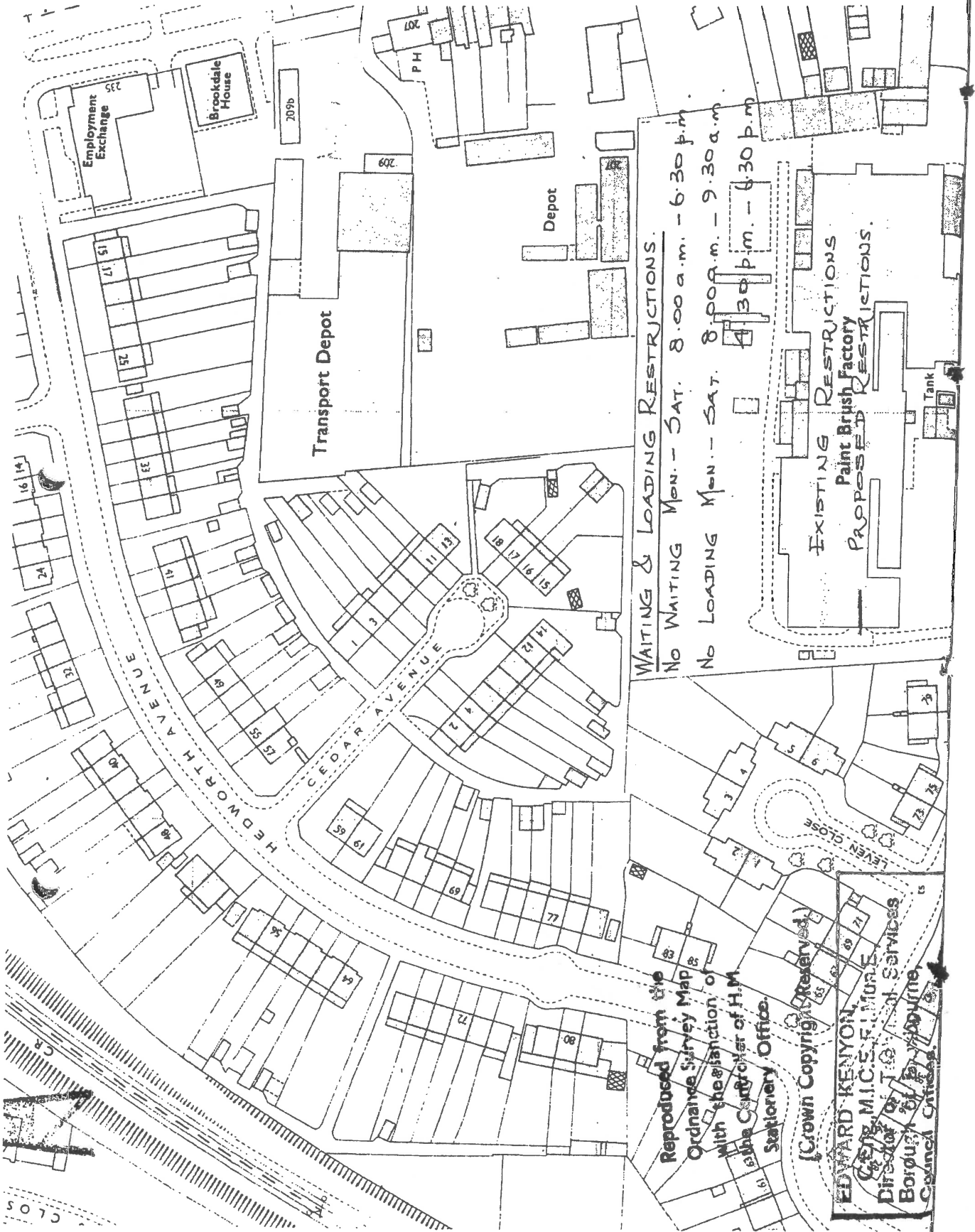
SCHEDULE

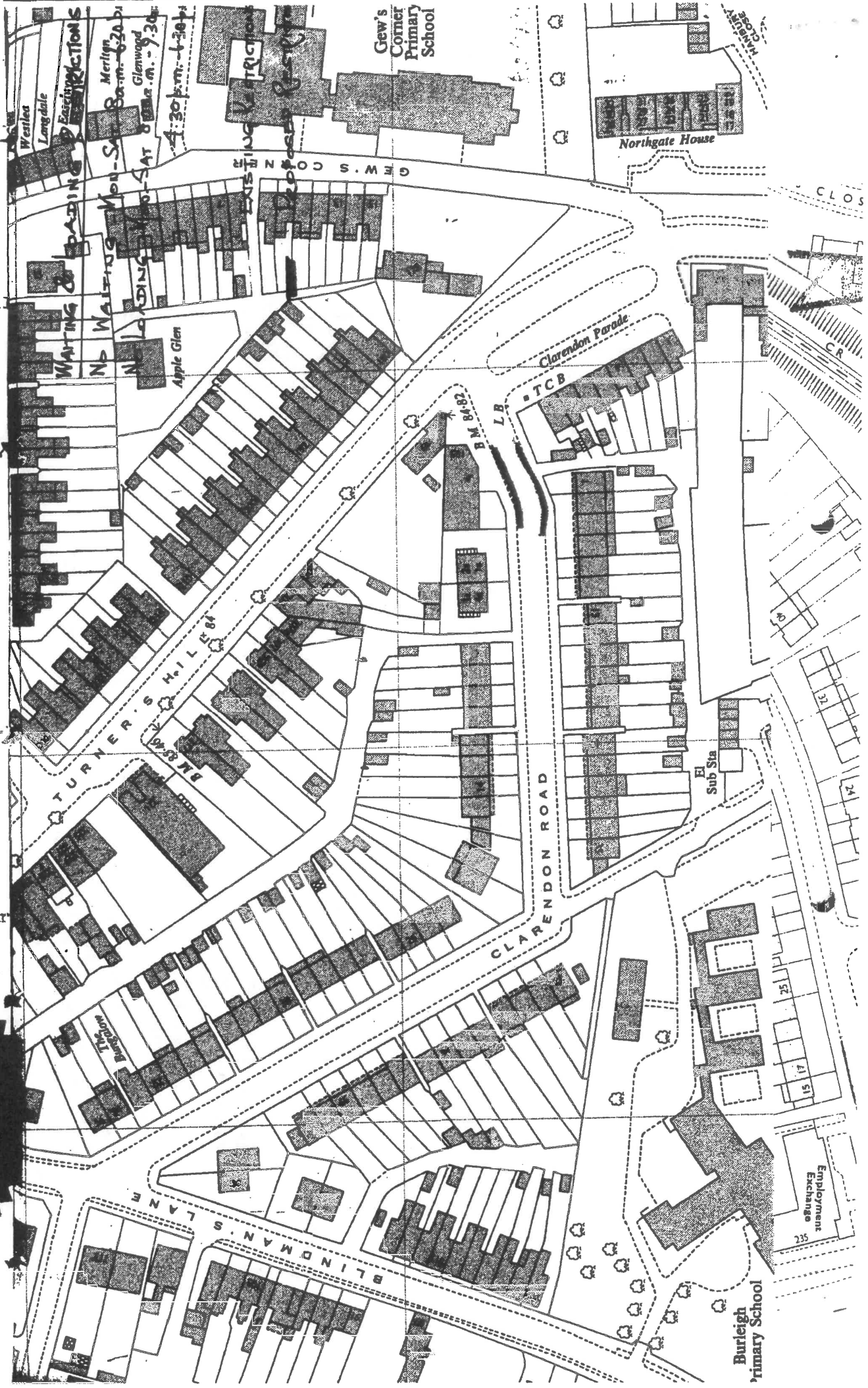
