**THE HERTFORDSHIRE (AMWELL STREET, HIGH STREET and BURFORD STREET,  
HODDESDON) (PROHIBITION OF STOPPING AND WAITING ON FOOTWAYS) ORDER 2013**

The Hertfordshire County Council in exercise of their powers under Sections 1, 2 and 3 of the Road Traffic Regulation Act, 1984 (which said Act of 1984 is hereinafter referred to as "the 1984 Act"), and Part IV of Schedule 9 of the Act of 1984 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following order:-

1. (1) This Order may be cited as The Hertfordshire (Amwell Street, High Street and Burford Street, Hoddesdon) (Prohibition of Stopping and Waiting on Footways) Order 2013 hereinafter referred to as "this Order" and shall come into operation on Monday 18 November 2013.

(2) The Hertfordshire (Amwell Street, High Street and Burford Street, Hoddesdon) (Prohibition of Stopping and Waiting on Footways) Plan ITP13068/2/1200/015 dated 09/13 (herein after referred to as "the Plan to this Order") is incorporated into this Order.

2. In this Order :-

"restricted area" means the area shown on the plan to this Order and identified in the key thereon as an area in which vehicles are prohibited from stopping or waiting.

3. Save as provided in Articles 4 or 5 of this Order, no person shall at any time cause or permit any vehicle except authorised Market Trader's vehicles or other vehicles authorised by the provisions of this Order to stop or wait with two or more wheels on any part of the restricted area as shown on, and identified in the key to, the plan to this Order.

In this Article –

"Market Trader's vehicle" means a vehicle owned or kept by a market trader being used at the time in connection with the setting up, running or dismantling of an authorised market stall on Hoddesdon Town Centre Market and on which is displayed in a prominent position on the front windscreen thereof a valid Market Trader's Permit issued by Broxbourne Borough Council so that all of the details contained on it are clearly visible from outside the vehicle.

"Market Trader" means a person authorised under licence to run a market stall in the Hoddesdon Town Centre Market.

"Authorised Market Stall" means any stall licensed or authorised by Broxbourne Borough Council to be erected with the boundary of Hoddesdon Town Centre Market.

"Market Trader's Parking Permit" means a permit which has been issued and validated by Broxbourne Borough Council.

4. Nothing in Article 3 of this Order shall render it unlawful to cause or permit any vehicle to stop or wait in the restricted area referred to therein for so long as may be reasonably necessary to enable:-

- a. the vehicle, if it cannot conveniently be used for such purpose in any other place, to be used in connection with any of the following operations, namely:-
  - i. building, industrial or demolition operations;
  - ii. the removal of any obstructions to traffic;
  - iii. the maintenance, improvement or reconstruction of the said roads;
  - iv. the laying, erection, alteration, repair or cleaning of any sewer or of any main pipe or apparatus for the supply of gas, water or electricity, or of any telecommunications apparatus kept or installed for the purposes of a telecommunications code system or of any other telecommunications apparatus lawfully kept installed in any position.

- b. the vehicle if it cannot conveniently be used for such purpose in any other place to be used in the service of a local authority or water authority in pursuance of statutory powers or duties.
- c. the vehicle to be used for fire and rescue, ambulance or police purposes;
- d. the vehicle to be used by a universal service provider in the course of the provision of a universal postal service for the purpose of delivering or collecting postal packets.
- e. a vehicle being used by any person duly authorised in writing by the Highway Authority to have access to the restricted area
- f. a Highway Authority vehicle engaged in highway maintenance or inspection works
- g. a vehicle in the service of Broxbourne Borough Council
- h. anything done under the direction of or with the permission of a Police Constable uniform

In this Article -

The expressions "universal service provider", "provision of a universal postal Service" and "postal packet" shall bear the same meanings as in the Postal Services Act 2000.

- 5. Nothing in Article 3 of this Order shall render it unlawful to cause or permit a vehicle to stop or wait in the restricted area if the vehicle is prevented from proceeding by circumstances beyond the driver's control or if the driver of the vehicle has stopped in order to avoid injury or damage to persons or property or is required to do so by law.
- 6. The provisions of the following Order are hereby revoked but only in so far as they are affected by the restrictions imposed by this Order:

The Borough of Broxbourne (Control of Parking) (Consolidation) Order 2011

- 7. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament.
- 8. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the 1984 Act or by or under any other enactment.

NOTICE is given that the Hertfordshire County Council has made Orders under the Road Traffic Regulation Act 1984 to introduce waiting restrictions, parking places, goods vehicle loading bay, no stopping and waiting on footways, no entry and a 20mph speed limit on various roads in Hoddesdon as specified in the Schedules to this Notice. The Orders will come into effect on Monday 18 November 2013.

Any person wishing to question the validity of the Orders, or of any provision contained in them, on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of the Act or any Instrument made under it has not been complied with in relation to the Orders, may within 6 weeks from the date of this Notice apply to the High Court for this purpose.

**SCHEDULE 1:** No waiting, loading or unloading at any time – those sections of road listed below and as set out in the Order and accompanying plan – parts of Pauls Lane, Amwell Street, High Street, Burford Street and Brewery Road, Hoddesdon

**SCHEDULE 2:** No waiting 9.00am to 6.00pm Monday to Saturday – those sections of road listed below and as set out in the Order and accompanying plan – parts of Brewery Road, Hoddesdon

**SCHEDULE 3:** Parking places 9.00am to 6.00pm Monday to Saturday limited to 1 hour waiting with no return within the next 2 hours – those sections of road listed below and as set out in the Order and accompanying plan – Parts of Amwell Street and Brewery Road, Hoddesdon

**SCHEDULE 4:** Goods Vehicle Loading Bay at any time – that section of road listed below and as set out in the Order and accompanying plan – part of High Street, Hoddesdon

**SCHEDULE 5:** Prohibition of Stopping and Waiting on Footways – those sections of footway listed below and as set out in the Order and accompanying plan – parts of Amwell Street, High Street and Burford Street, Hoddesdon

**SCHEDULE 6:** Prohibition of Entry Except Buses and Pedal Cycles – that section of road listed below and as set out in the Order and accompanying plan – Brewery Road, Hoddesdon from Sainsburys Car Park Roundabout

**SCHEDULE 7:** 20mph speed limit - those sections of road listed below and as set out in the Order and accompanying plan – Parts of Amwell Street, High Street, Burford Street, Brewery Road, Brocket Road and Conduit Lane, Hoddesdon

## **STATEMENT OF REASONS FOR PROPOSING**

### **THE HERTFORDSHIRE (AMWELL STREET, HIGH STREET, BURFORD STREET AND BREWERY ROAD, HODDESDON) (PROHIBITION OF STOPPING AND WAITING ON FOOTWAYS) ORDER 2013**

The Hertfordshire County Council in conjunction with Broxbourne Borough Council is currently preparing the various proposals to enhance Hoddesdon Town Centre which improves road safety and provides a safer environment for pedestrians using the Town Centre.

As part of this, it is intended to implement the following restriction:

- 'Prohibition of Stopping and Waiting on Footways' in Amwell Street, High Street, Burford Street and Brewery Road, Hoddesdon

It is intended that these restrictions will improve road safety by keeping areas free from obstructive or inappropriate parking and allow better provision for pedestrians using the Town Centre.

All the proposed measures have been subject to consultation with local and County Councillors representing the area and Broxbourne Borough Council. The local Police, Fire and Rescue Services, Hertfordshire County Council Passenger Transport Unit, local residents have also been consulted.
