

**THE HERTFORDSHIRE (NORTHFIELD ROAD, WALTHAM CROSS)
(PARKING BAYS) ORDER 2019**

The Hertfordshire County Council in exercise of their powers under Sections 32 and 35 of the Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984"), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984, hereby makes the following Order:-

1. This Order may be cited as "The Hertfordshire (Northfield Road, Waltham Cross) (Parking Bays) Order 2019" and shall come into effect on Monday 9 December 2019.
2. Those lengths of Northfield Road, Waltham Cross as specified in the Schedule to this Order are hereby authorised for use as half on / off footway parking bays for motor vehicles at any time.
3. Where in Article 2 of this Order, a length of Northfield Road, Waltham Cross is described as authorised for use as a half on / off footway parking bay for motor vehicles at any time, the driver of a vehicle shall not permit the vehicle to wait in that parking bay unless it is wholly parked within the marked limits of that parking bay.
4. A vehicle left in a Parking Bay in contravention of Article 3 of this Order or left otherwise than in accordance with the provisions of this Order shall incur a penalty charge.
5. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament.
6. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other regulations made or having effect as if made under the act of 1984 or by any other enactment.

Any person wishing to question the validity of the Orders, or of any provision contained in them, on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of the Act or any Instrument made under it has not been complied with in relation to the Orders, may within 6 weeks from the date of this Notice apply to the High Court for this purpose.

SCHEDULE 1: No waiting at any time – effecting those sections of road listed herein and as set out in the Order and accompanying plan - Parts of Northfield Road and Eastfield Road.

SCHEDULE 2: Half on / off footway parking bays operational at any time – effecting those sections of road herein listed and as set out in the Order and accompanying plan – Parts of Northfield Road.

STATEMENT OF REASONS

THE HERTFORDSHIRE (NORTHFIELD ROAD AND EASTFIELD ROAD, WALTHAM CROSS) (RESTRICTION OF WAITING) ORDER 2019

THE HERTFORDSHIRE (NORTHFIELD ROAD, WALTHAM CROSS) (PARKING BAYS) ORDER 2019

Hertfordshire County Council is proposing to introduce waiting restrictions and provide parking bays in parts of Waltham Cross.

The proposals will comprise of –

- 'No waiting at any time' restrictions on parts of Northfield Road and Eastfield Road.
- Provision of 'half on / off' footway parking bays effective at any time, on parts of Northfield Road.

It is proposed to introduce 'no waiting at any time' restrictions, to ensure visibility requirements are kept clear. The waiting restrictions are intended to prevent parking on areas of Northfield Road and Eastfield Road that are considered a hazard for highway users, whilst facilitating the passage of larger vehicles such as refuse collection, delivery and emergency service vehicles.

Half on and half off parking spaces are to be created to provide parking areas for residents and to control where residents currently park in this area of Northfield Road. The proposed parking bays will formalize the parking arrangements on the highway. Half on and half off parking bays will be implemented in areas where forward visibility around the bend in Northfield Road will not be affected.

Therefore, having also considered the duty imposed under Section 122 Road Traffic Regulation Act 1984, it appears to the Highway Authority that it is necessary and expedient to make Orders in the interests of; avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising and for facilitating the passage on the road or any other road of any class of traffic (including pedestrians) and for preventing congestion.

The proposal has been subject to consultation with local and County Councillors representing the area and Broxbourne Borough Council. The local Police, Ambulance, Fire & Rescue Services, Hertfordshire County Council Passenger Transport Unit and local residents are also being consulted.
