NOTICE IS HEREBY GIVEN that Broxbourne Borough Council with the consent of Hertfordshire County Council in Order to relieve or prevent congestion of traffic and improve the amenities in the area proposes to make the above Order under the Road Traffic Regulation Act 1984 to amend existing pay and display parking places in parts of Cheshunt as specified in the Schedule to this Notice.
